Some manufacturers require an original letterhead, but in most cases, we can accept an emailed copy. We will also need a Federal Excise Tax Form if the Police Department is exempt. This form/tax differs from Sales tax and must be completed to receive the 11% discount. This form can be used for a one-time purchase or it can be saved for up to three years.

We offer 0% Net 30-day terms to all police departments. We accept ACH, credit card, or checks as payment. You may also pay with credit card when placing your order, but it is not required.

For ammunition and accessories, we need something in writing from the department authorizing the purchase. We will also need the billing and shipping information listed to ensure we mail the invoice and product to the correct location(s). A Federal Excise Tax Form is required for all ammunition purchases as well.

## OFFICER

For gun purchases, we will either need Officer Letterhead for ATF or a copy of the officer's current valid driver's license, police ID, and Federal Firearm License to make the transfer. (FOID for IL residents.)

For ammunition and accessories we will need something in writing from the officer authorizing the purchase. They will also need to confirm their billing and shipping address.

Officers must prepay.
